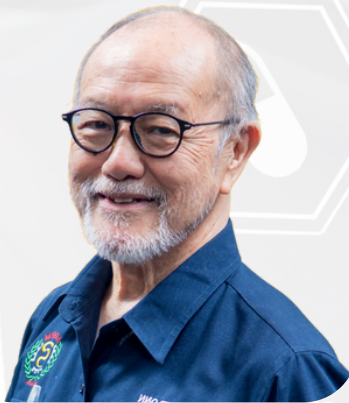


**Ms. Laavenia Ramasegar**
